

2011 Census release: Ward profile



This profile provides information on key demographics, health care, household and employment status for this ward primarily based on the 2011 Census data. It shows both the differences between the Camden average and the ward, and where available, between the 2001 and 2011 Census figures. All data for 2011 were published by the Office for National Statistics (ONS) in January 2013. All data are available at www.ons.gov.uk. Unless otherwise stated, data are for 2011.

DEMOGRAPHICS


Age structure



In 2011 there were a total of 13,417 residents in Kentish Town, compared to 11,462 in 2001.


The 60-74 years age group saw the largest increase from 2001 (from 3% to 9%).

Marital and Civil Partnership status



In 2011, 61% of residents in Kentish Town were recorded as not living in a couple. This is higher than Camden (59%) and is the same as the ward's percentage in 2001 (61%).

Religion




The percentage of people with no religion in Kentish Town has increased from 29% to 34% since 2001, and is the same as in Camden (34%).

Ethnicity and Language


Ethnic Group

In 2011, 40% of people in Kentish Town were White British, followed by Other White, which represents 28% of the ward population.




Proficiency in English

In 2011, 339 (3%) of people could not speak English or not speak English very well. This percentage is the same as in Camden overall (3%).




Country of birth and residency

Country of Birth




Length of UK residency



The percentage of residents in Kentish Town that were born in the UK decreased from 70% in 2001 to 66% in 2011. The percentage of people born in EU countries (including the most recent accession countries) other than the UK and Ireland has increased from 5% in 2001 to 11% in 2011. The percentage of residents in Kentish Town who were not born in the UK but have lived in the country for ten years or more is lower in Kentish Town (20%) than in Camden (21%).

LABOUR MARKET


Employment by socio-economic group (NS-SEC)



In 2011, 780 residents in Kentish Town were long-term unemployed or had never worked, which represents 7% of the ward population (compared to 7% in Camden).

Note: The working age population size does not exactly equal the sum of the individual categories due to rounding.

Economically inactive* working age population (16-74)



In 2011, there were 2,895 (27%) economically inactive residents* in Kentish Town, of whom 510 (18%) were long-term sick or disabled (14% in Camden).

* Not in work and not actively seeking work.

Education and qualifications


In 2011, Kentish Town had a higher percentage of residents aged 16 or over with no qualifications than Camden, and a higher percentage of residents aged 16 or over with a degree level qualification than Camden.

HEALTH AND THE PROVISION OF UNPAID CARE


Percentage of residents who rated their health as bad or very bad, Camden wards compared with Camden and London averages, 2011



6% of Kentish Town residents rated their health as 'bad' or 'very bad' in 2011, which was equal to Camden (6%). In 2001, 9% of Kentish Town residents rated their health as 'not good'.

84% of Kentish Town residents rated their health as 'good' or 'very good', which was the same as the Camden average. 10% of Kentish Town residents rated their health as fair.

Residents who feel that they are limited by their health in their daily lives, Kentish Town compared with Camden.






Types of households in Kentish Town



Deprivation




26%

Note: Deprivation conditions: any household member is unemployed or long-term sick; no household member has at least a level 2 education and none are full-time students; any household member has long-term health problem or rates their health as bad or very bad; household is overcrowded, shared, or lacks central heating.


Household size

297 (5%) households in Kentish Town had more than one person per room compared to 6% in Camden.





Car ownership

3,598 (62%) households in Kentish Town had no access to a car or van in 2011 compared to 55% in 2001.



Tenure and accommodation




In 2011, 801 (20%) households in Kentish Town had a head of household aged 65 or over, compared to 24% in Camden.

1,931 (33%) households in Kentish Town lived in a property rented from the council or another social landlord, compared to 44% among households whose head was aged 65 or over, and 33% among all households in Camden.

Central heating

155 (3%) households in Kentish Town had no central heating in 2011 compared to 8% in 2001. In 2011, the percentage of homes without central heating in Kentish Town was the same as Camden (3%).
